AGREEMENT / LIABILITY RELEASE

Sales: All sales should be cash and carry or advance order. Wi-Fi access for check verification and/or credit approval is available for an additional cost. A copy of your business license must accompany this agreement.

Taxes: Sales tax from the sale of items at FFHB must be declared and will be collected by an FFHB representative at the close of the event. All persons furnished by Merchant shall be considered Merchants employees or agents and Merchant shall be responsible for payment of all unemployment, workman's comp, social security, and other payroll taxes, including contributions from them when required by law.



**Release, Waiver, and Disclosure of All Liability:** In consideration of Merchant being permitted to enter and participate in FFHB, Merchant hereby releases and forever waives and discharges the producers of FFHB from all responsibility for any and all rights, claims, actions, causes of actions demands, damages, costs of judgments, medical expenses, liabilities, attorney's fees and legal costs or other compensation whatsoever, whether known or unknown, and specifically including any claims based upon any alleged negligent acts or omissions by the producers, that Merchant now has or that hereafter accrue to Merchant arising out of or related to Merchants entry or participation in FFHB. This release, waiver and discharge is binding on Merchants heirs, assigns, executors, administrators and representatives.

**Indemnify and Hold Harmless:** Merchant assumes responsibility for and agrees to indemnify and hold harmless the producers against any and all losses, including judgments, damages, costs, expenses and attorney's fees, directly or indirectly related to any claim, demand or cause of action arising out of or related to Merchants participation in FFHB 2018.
